





The MOHCDGEC has developed new priority product list of 312 items that caters demands of all health care levels (Hospitals, Health centres and Dispensary).

A total of new 42 items have been added in the list.




8. Cash and Carry Policy

- MSD Act No. 13 of 1993 stipulates that MSD should operate under Cash and Carry Policy.
- The policy support provision of funds for purchasing products including opening up LCs.
- The debt growth to the tune of **TZS. 200 billion** has eroded MSD Working Capital to support procurement without Cash and carry.
- Delays in disbursement of funds from the Treasury, most of facilities have ended up taking goods from MSD on credit.



9. Debt Growth -Fundamental Challenge

- Growth of Debt at MSD has been a challenging problem for sustainable supply of health commodities in the country
- The Government is addressing the growth of debt by improvising the budget for debt repayment
- The debt status as at 30th June, 2018 was **TZS. 200 bn** with the facilities debt at TZS. 31 bn





10. Fund disbursement – Fundamental Challenge

- Issue of Funds disbursement to health facilities has been a challenging problem to MSD maximum provision of service
- Delays and erratic in disbursement of funds from Treasury.
- While we appreciate the Government to increase the budget for health commodities from TZS. 29.25bn in 2015/2016 to TZS. 260bn in 2017/2018, implementation is still a challenge.
- Health Facilities to compliment government disbursement using other sources funds from their coffers (eg.NHIF funds)

11. Order Fill rate 2017/2018

Average Order fill rate stands at 54%

- Challenges in Quantification and Forecasting

- Orders are not only based on 306 priority items but rather MSD catalogue list of 800+ items
- Some of HC and Dispensaries not using their other sources of funds including NHIF
- Last minutes ordering of DHFF allocations

12. Challenges of Special Procurement

Special items these are Pharmaceuticals, Medical equipment, Medical supplies and Reagents that are not stocked at MSD. We still have a challenge of procurement delays for special items.

- Non standardized medical equipment and differentiated specification of the same equipment contribute
- Uncoordinated orders. Small ordered quantities (e.g dental items) which forces MSD to wait for orders from other facilities for consolidation before ordering
- Delays in confirmation of Specifications and prices for some health facilities.
- Procurement regulations. MSD is obliged to comply to these regulations and definitely contribute in procurement delays
- 5. Lack of products registration by TFDA eg. Anticancers
- 6. Late submission of requirements by HFs Contrary to Clause 141 (1) of Public procurement regulations of 2013

Issues:

- Unrealistic
 demand forecast
 data
- **Proposed Intervention:**
- -Training
- -Tools & Systems
- Enforcement

- Inadequate MSD Financing
- -Adherence to Budget allocations
- -Debt repayment (Atleast 25% per year)
- -Supplementary Funding from HFs (eg.50% of NHIF)

- Inadequate inventory levels
- -Timely and steady disbursement of funds
- -Timely submission of requirements (January)
- -Harmonization of MSD/NHIF catalogue
